

# **TERMS OF BUSINESS**

- (a) Full payment 48 hours prior to the committal for non-attended, attended funerals, Direct, Simple and Celebration of Life.
- (b) Full payment of disbursements 48 hours prior to the cremation or burial for all other funeral options.
- (c) Full payment will be required 21 days from the date of our final invoice.
- (d) Failure to pay in full by the date may incur a charge of interest:
  - At a rate of 4% above our bank's base rate from time to time in force
  - Calculated (on a daily basis) from the date of our account until payment
  - Compounded on the first day of each month
  - Before and after any judgement (unless a court orders otherwise) we may recover (under the Indemnity Clause below) the cost of taking legal action to make you pay.
